- A new program; started last semester with 79 students.
- Courses were piloted as continuing professional education courses.

- University of the Philippines Open University (UPOU)
  - All programs are delivered using the online distance learning mode (e-based).
  - Most programs are graduate programs (diploma or master's).
  - Also offers continuing professional education and other short courses.
- In addition to the Diploma and Masters in Land Valuation and Management Program, the UPOU should incorporate VG principles on governance of tenure of land, fisheries and forestry into at least two programs:
  - Diploma and Masters in Environment and Natural Resources Management
  - Master of Public Management
- Most difficult issue: Convincing faculty members to include VG principles into their courses.
  - Need for resources (i.e., written material) and case studies to convince them, and for them to use in their courses.

## Possibilities of collaborating with other institutions on teaching or research on governance of tenure issues

- Philippine institutions likely to be interested in collaborating with UPOU:
  - National College of Public Administration and Governance, University of the Philippines
  - School of Urban and Regional Planning, University of the Philippines
  - School of Governance, Ateneo de Manila University
- Collaboration with institutions outside of the Philippines should be explored
  - Particularly for the development of the course on Comparative Land Value Taxation, which will survey systems in various countries.
